

Privacy Statement

MSCS is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the MSCS Web site and governs data collection and usage. By using the MSCS website, you consent to the data practices described in this statement.

Collection of your Personal Information
